

# River Guardians Scorecard






## Hambrook

The overall catchment score provides a review of river health and is based on a year's data from all sites in the waterbody. Data is collected through WSRT River Guardian surveys and using important external data. At least 12 samples taken over a year are required for a river to qualify for a scorecard.



INV	Inverts No. of Invertebrates in the watercourse (Environment Agency Catchment Explorer)
INNS	INNS No. and diversity of Invasive Non-Native Species which degrade habitat, biodiversity and economy.
TURB	<b>Turbidity</b> Water can be more turbid (murky) due to lots of particles suspended in it from soil or road dirt washing into the rivers during rainfall.
POL	<b>Pollution</b> A summary of EA Storm Overflow Event Duration Monitoring Data (2023) and River Guardian visual assessment.
Ν	<b>Nitrogen</b> from fertilizer, wastewater, auto emissions, and manure can lead to algal blooms that decrease stream health and contaminate drinking water.
HAB	Habitat score Derived from River Habitat Surveys outlining the abundance and diversity of habitat along a river.
TDS	<b>Total Dissolved Solids</b> The more minerals, salts and metals that are dissolved in the water the more conductive the water gets. This can indicate the presence of pollutants and can be altered by geology and saltwater.
Ρ	<b>Phosphate (PO4)</b> A vital nutrient for the growth of all organisms found in natural and artificial fertilisers, sewage and industrial wastes. Natural levels are very low so any measurable phosphate is likely due to anthropogenic influences.




